Consignment Agreement

1. The above referenced (consignor) authorizes The Piano Gal Shop LLC (the consignee) to sell and liquidate all of the items listed below in this agreement.
2. This agreement is between the consignor and The Piano Gal Shop LLC.
3. Consignment period is for 90-days. Consignor receives 60% of the selling price for consignments sold and The Piano Gal Shop receives 40%.
4. The Piano Gal Shop will tune, clean, make necessary adjustments, actively promote and maintain your instrument(s) until it sells or it has been in store for more than 90 days. If the instrument does not sell within the 90 day period, the consignor has the option to sign an extension amendment to the agreement, which adds an additional 30 days at a reduced sale price of 20%.
5. The Consignor shall pay a fee of 25% of the asking price for removal of the instrument(s) prior to the first 30 days of the consignment agreement.
6. The Piano Gal Shop, LLC is not responsible for any damage due to an "act of God", theft or loss of any items consigned.
7. Proceeds are payable 30-days after the date of sale. Checks may be mailed upon request. Consignor shall be responsible for any fees associated with lost checks requested by mail.
8. Unclaimed consignor earnings shall be forfeited 120-days after the sale of any consigned item.
9. If The Piano Gal Shop has made reasonable attempts to contact the Consignor and has been unsuccessful for a period of 120 days with no response from the Consignor, The Piano Gal Shop, LLC reserves the right to donate or repurpose any consignments still in our possession.
10. As the sole owner of the items described in this agreement, I am within my legal rights to consign these items.
11. If repairs are recommended, in most cases, we will require the consignor (seller) to pay for repair costs before the instrument is put on consignment.
12. Consignor can arrange for piano to be delivered to The Piano Gal Shop, or the consignor can use our moving partners, Gorilla Movers of WI, for pick up. The fee for pick up is **\$150**. The fee

is half of the mover's fee. The Piano Gal Shop will pay the other portion. Checks should be made out to The Piano Gal Shop and are due upon pick up of the piano.
